Assessment basis (BMG)

exact: annual net income of the debtor divided by 12 (without family bonus plus) roughly (for 14 salaries): Monthly net income times 14 by 12 without family bonus plus, with benefits in kind, overtime, bonus payments, allowances at 50%

Standard requirement and maintenance freeze (luxury limit, playboy limit)

Maximum maintenance: standard requirement x 2 / x 2,5 (up to 10 years / over 10 years)

Family allowance and child deduction

are due to the main carer without being offset against maintenance.

Care by both parents, self-care or third-party care

If the child receives above-average care (dual residence) or lives in a household without parents, maintenance is calculated differently.

Family bonus plus

has no influence on maintenance. It (only) reduces the income tax. For children under the age of $18 \\\in 2,000.00$ per year, from the age of $18 \\\in 650.00$ per year. Allocation by agreement: caring parent 100% / maintenance debtor 100% / both 50%.

Spousal maintenance

1. Maintenance creditor has no income

33% of the BMG of the debtor, minus 4% per child.

2. The person entitled to maintenance has their own income

40% of the BMG of the debtor, minus 4% per child, minus own income.


